Such things include the weather, deterioration of range surfaces through use, personal attributes such as my fitness and level of expertise and my approach to the challenges presented in this competition.

I am also aware that it is a condition of my entry into this competition that I waive all rights I might otherwise hold against the Competition Organisers. I release the Competition Organisers from all liability any of them might later have to me for or arising out of any injury to me caused in any way by my participation in the competition or by any other way whatsoever due to any negligent act, breach of duty, default and/or omission on the part of the Competition Organisers.

Please note: The Western Australian Police Service currently does not recognise firearms licences issued in other Australian States or Territories. **For those competitors who register prior to 1<sup>st</sup> February 2010 and supply details of their firearm(s) they bring into Western Australia, a Group Temporary Permit will be obtained free of charge.**

<b>Closing date</b>	Entries must be received by <b>15 March 2010</b> .
<b>Payment</b>	Entries must be accompanied by full payment. Entry forms will not be processed until full payment has been received and cleared. Acceptable methods of payment are: cash, cheque, money order or <b>Electronic Funds Transfer (EFT) (EFT information can be made available on request to IPSC WA)</b> .
<b>Payment period</b>	Entry forms received on or after the payment periods that do not include the higher fees will be rejected and returned. Entry forms will not be considered submitted until received with the correct fee.
<b>Dinner</b>	Presentation Dinner tickets to be purchased in advance. No dinner tickets will be available after the closing date.
<b>Withdrawals</b>	Withdrawals prior to <b>1st February 2010</b> will be eligible for a refund less an administration fee of \$25. Withdrawals after <b>1st February 2010</b> will be eligible for a refund less an administration fee of \$50. Withdrawals after the closing date, <b>Monday 15 March 2010</b> , and failure to attend will result in forfeiture of all fees, although should the match shirt have been purchased, this will be supplied.
