Match Entry Release and Waiver

Blacktown Pistol Club Ltd,

I am also aware that it is a condition of my entry into this competition that I waive all rights I might otherwise hold against the Competition Organizers. I release the Competition Organizers from all liability any of them might later have to me for or arising out of any injury to me caused in any way by my participation in the competition or by any other way whatsoever due to any negligent act, breach of duty, default and/or omission on the part of the Competition Organizers.

I am also aware that any person participating in IPSC competition at this range is only allowed to do so on the distinct understanding that they do so at their own risk.

I also understand the match organisers reserve the right to cancel or postpone the match without warning, before or during the match due to weather or unforeseen circumstances. If the match is cancelled or postponed the match organisers cannot be held responsible for any costs or expenses incurred by the competitor due to the cancellation or postponement of the match. In the event the match is cancelled:

- (a) before the start of the competition, the entry fee will be refunded less an administration cost.
- (b) where the match has commenced, a refund of the entry fee will be at the discretion of the match organisers.
