I also understand the match organisers reserve the right to cancel or postpone the match without warning, before or during the match due to weather or unforeseen circumstances. If the match is cancelled or postponed the match organisers cannot be held responsible for any costs or expenses incurred by the competitor due to the cancellation or postponement of the match. In the event the match is cancelled:

1. Before the start of the competition, the entry fee will be refunded less an administration cost.
2. Where the match has commenced, a refund of the entry fee will be at the discretion of the match organisers.
